As I was standing on the sidewalk of the Morrison Bridge I could clearly see a M/W, later identified as (xi) Tyner, completely naked. He was penetrating a blow up doll, masturbating, and changing positions. This activity went on for several minutes while we waited for another officer to arrive. (xi) Tyner was clearly in public view and was not discreet in his activity.

Sgt. Uopel arrived. He crossed the off ramp to approach from the north stairs and Ofc Larson and I approached from the south stairs. He was fully involved in his activity when he saw us and grabbed a blanket to cover his penis. We told him to get dressed.

(xi) Tyner had adult magazines set up on the stairs so he could see them. He had the blow up doll, the box it came in and a pink sexual gratification device which Ofc Larson placed into evidence after deflating the doll.

8 At 0847 I was parked in front of Central Precinct at 1111 SW 2nd Ave when I was approached by a M/W about 55 years old. He said he had walked from the east side of the Morrison Bridge. As he was using the pedestrian under-crossing that allows you to walk from the W/B direction viaduct sidewalk to the W/B sidewalk of the Morrison Bridge that goes under the I-84 WB/I-5 SB exit ramp to the Morrison Bridge., he came across a M/W with no clothes on attempting to have sex with a blow up doll and had a "skin magazine" laying next to him.

I then left Central, and proceeded to that location. I advised dispatch I was going to the location to check on what the person had told me and requested a cover unit to assist me. I arrived first at the location at 0853 and got out of my car. I stepped to the sidewalk of the viaduct and looked over the guard rail and I could see a M/W with no clothes on in plain view. I could also see a blow up doll fully inflated laying partially on the north stairs and the bottom landing of the under-crossing.

As I waiting for cover to arrive, a F/W who was walking on the side walk saw what I had seen also and asked, "how am I supposed to cross the freeway exit?" She had a disgusted look on her face and it was obvious she did not want to use the under-crossing because of SB's actions. I told her to go ahead and walk across the exit safely when there were no cars.

While waiting for cover I could see SB put lubrication on his semi-flacid penis and then start to massage it in a rapid motion with his hand in a fist. He then picked up a rubber device and inserted his now erect penis in this rubber device and began to stroke the rubber device rapidly back and forth over his penis. He momentarily stopped and picked up a magazine and propped it on the pedestrian guardrail edge so he could better view it. He then dis-engaged the rubber device and began to kneel down and insert his penis in the pseudo vagina of the blow up doll. He began to gyrate his hips back and forth while his erect penis was going in and out of the blow up doll.

Cover arrived (Ottoman, Voepel & Duane) and we approached from both directions to the under-crossing. We then took SB into Custody at 0903. At 0905 I advised SB of his Miranda rights which he understood by saying "yes." Officer Ottoman took SB to her patrol car. Sgt. Voepel then got his digital camera and took the attached pictures.

The magazine was open to the nude picture of a female. As I attempted to deflate the blow up doll, I could see that all three of the pseudo orifices of the doll had lubrication on them by the shiny greasy sheen on the them.
